In consideration for being given permission to enter the Site and participate in the Activities, Participant (acting through and/or with the consent of his/her legal guardian, if the undersigned is a minor), agrees as follows:

- 1. Activities. I understand and agree that the Activities include my travel (whether over land or water, or by air) to and from the Site and I agree to familiarize myself with, and comply with the terms of, the license, permit, lease, contract, or other agreement under which I am being permitted to enter the Site and participate in the Activities (where that is applicable), or of any program or arrangement under which I will be participating in the Activities as a guest or volunteer of CIR (where that is applicable), and to restrict my use of the Site to the Activities which are permitted under such license, permit, lease, contract, agreement. program, or arrangement (as applicable). I understand that the Activities officially begin and end at the location(s) designated by the CIR.
